- B31 Standards Committee is currently working on an action item to have the B31 Forever Medal Nominating committee disbanded and have the B31 Honors and Awards committee handle all award activities.
- Encourage all members to make nominations for various Committee level and ASME awards available. Nominating procedures and submission deadlines should be followed for each award.

6.3 B31.1 TG on Stress Equations - TG consists of Messrs. Engelkemier (Lead), Bethea, Davis, & Haupt

Noted two items created and drafts developed. TG comments are being consolidated and ballot to B31.1 SC expected to be issued in July.

6.4 B31.3 – R. Haupt, P. Flenner, D. Rahoi

Key topics being worked on by the B31.3 SC include the definition of stress, and the incorporation of B31J equations.

6.5 B31 MDC & B31 Standards (E, G, H, J) – B. Holbrook / R. Haupt/M.Engelkemier

B31 MDC held a teleconference in March. Noted Jimmy Meyer was elected as Chair, and Monte Engelkemier as Vice Chair. Ballot for B31H expected to be issued shortly.

6.6 B31 Fabrication and Examination Technical Committee – P. Flenner

B31P, Standard Heat Treatment for Fabrication Processes was published on 5/15/18. Consistency Ballots for reference to B31P from the B31 Standards Committee expected shortly.

6.7 B31 ST LLC Requests

B31 ST-LLC Requests are due to Adam Maslowski (maslowskia@asme.org) by August 31, 2018. Projects submitted will be reviewed and prioritized by the B31 Standards Committee during 2018 B31 Code Week.

6.8 BCA Task Group - Conformity Assessment Requirements within B31.1

Board on Conformity Assessment (BCA) Task Group (BPV I Standards and B31.1 Section) to research, collect data, and provide a report to the Board on the pros and cons of establishing conformity assessment requirements within B31.1 and its possible use of the PP designator.

TG contains BCA Members: Richard Campbell (Chair), Paul Edwards (representative from CBPVCA), Robert McLaughlin, Tom Hansen, & Matthew Vazquez (ASME Staff). B31.1 Members: Paul Davis, Ray Reamey, & Roger Thein. BPV I Member: Edward Ortman. BCA TG teleconference was held on July 28, 2017.

Updated Business Plan for Proposed New B31.1 Certification Program to be denoted as Non Boiler External Piping – Quality (NBEP-Q), and assigned as item 18-3401. B31 Standards Committee Administrative Ballot 18-275 with review and comment to BCA, BPTCS, BPV I, and SGGR&P (BPV I) was Approved. Negatives/Comments received were reviewed by the Subgroup on Quality Control (B31.1). Following a lengthy and detailed discussion, the SG agreed to step back on the original intent, and proceed with adding quality control requirements and a quality program for NBEP (with a goal of the 2020 Edition) in B31.1. It is the intent Certification be reevaluated once the quality control requirements are incorporated. A synopsis of the SG's actions and intent will be submitted by Mr. Davis. Mr. Campbell noted that the BCA Task Group will now be disbanded.

6.9 BPTCS – W. Lundy

In late 2016 an inquiry was sent to both BPV I and B31.1 having to do with jurisdictional limits of the Boiler and BEP. The record numbers are 16-2648 (BPV I) and 16-3052(B31.1). The two committees responded to the inquiry at separate times, BPV I in May 2017 and B31.1 in January 2018. BPV I believes that jurisdictional limits for the Boiler and BEP are administrative requirements that are set by Section I and that B31.1 only has technical responsibility for BEP. 16-2648 is the BPV I Record Number and 16-3052 is the B31.1 Record Number which contain the subject inquiries. The Section I inquiry has been issued and published, the B31.1 inquiry was approved, but the B31.1 SC took a follow-up action to hold this item until a response from the BPTCS was received.

BPTCS Administrative Ballot 18-1116 to vote on the reaffirmation that BPV Section I is assigned total administrative jurisdiction over boiler external piping requirements, including determination of where those requirements begin and end, and that the B31.1 is assigned total technical jurisdiction over boiler external piping requirements, was closed on May 4, 2018 and was approved.

12.3 <u>B31.1 Benchmarking Survey on high energy piping (HEP) programs</u>

As a bit of background, the addition of the Operation and Maintenance (O&M) Chapter VII to the ASME B31.1 Code in 2007 was a significant change affecting owners and operators of power plants. It required the operating company to develop operating and maintenance procedures to ensure safe operation of their covered piping systems (HEP). The O&M SubGroup of ASME B31.1 has responsibility to fully develop and maintain Chapter VII, and the non-mandatory Appendix V which provides best practices for the O&M of power plant piping systems. The development of the rules contained in B31.1, Chapter VII are largely based on best in class programs within the utilities sponsoring representatives to the B31.1 Committee and other member experiences. The expected outcome from the survey is twofold. First, the B31.1 SubGroup on O&M will learn the scope and maturity of the HEP programs currently in place. This will provide valuable input into the process for future Code consideration. Secondly, all utility participants in the survey will be given the results thereby providing you a benchmark of your programs. The B31.1 O&M SubGroup feels the Code rules should be a blend between what is a minimum reasonable expectation and achievable by all, as well as the key attributes of an HEP program which maintains safe operation. This survey will provide needed data on the status of HEP programs across the power generation industry.

Additionally, it is anticipated that the results of this survey will help inform the strategic direction of EPRI Programs 63 (Boiler Life and Availability Improvement), and 88 (Combined Cycle HRSG and Balance of Plant).

Ms. Bajpayee reported that the Subgroup will follow-up with a few survey respondents to get clarification on a few topics. It was noted that gaps in B31.1 will be identified and there will be three action items initiated as a result of the survey. B31 MTC Report to B31.1 meeting of 5/23/2018

MTC had a conference call meeting on March 15, 2018.

Work continues on updates to B31T with a new edition scheduled for 2018.

Failures during hydrostatic testing - MTC established a task group to look into the issues with carbon steel and make recommendations to the B31 codes. So far, no definitive causes have been demonstrated to have sufficient validity to warrant actions. The TG will continue to monitor the issue.

MTC reopened our item on the differences in the Joint Efficiency Factors between the different B31 books and is looking at this in conjunction with MDC. It is still unclear as to who should takt the lead and what would be reasonable objectives.

The next MTC meeting will be Thursday of the B31 Code Week in September.
